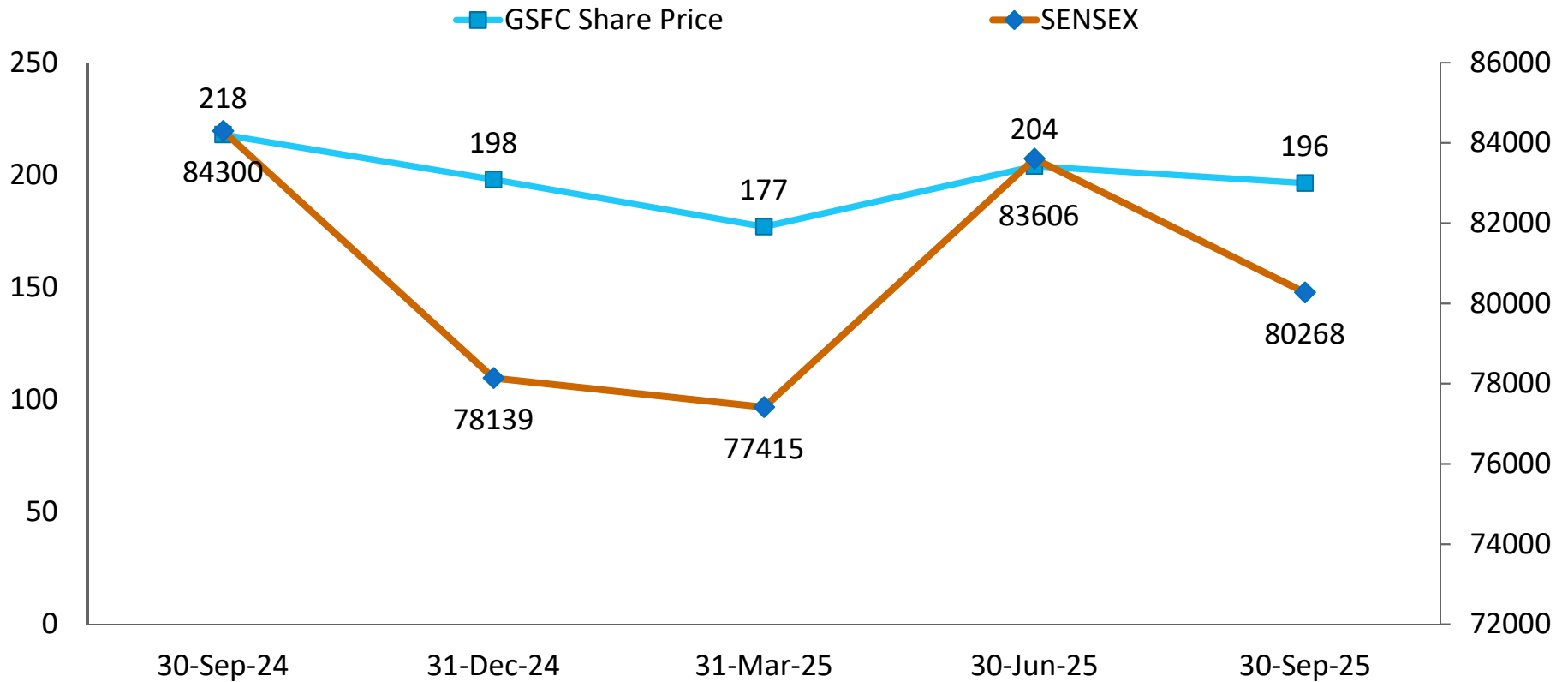

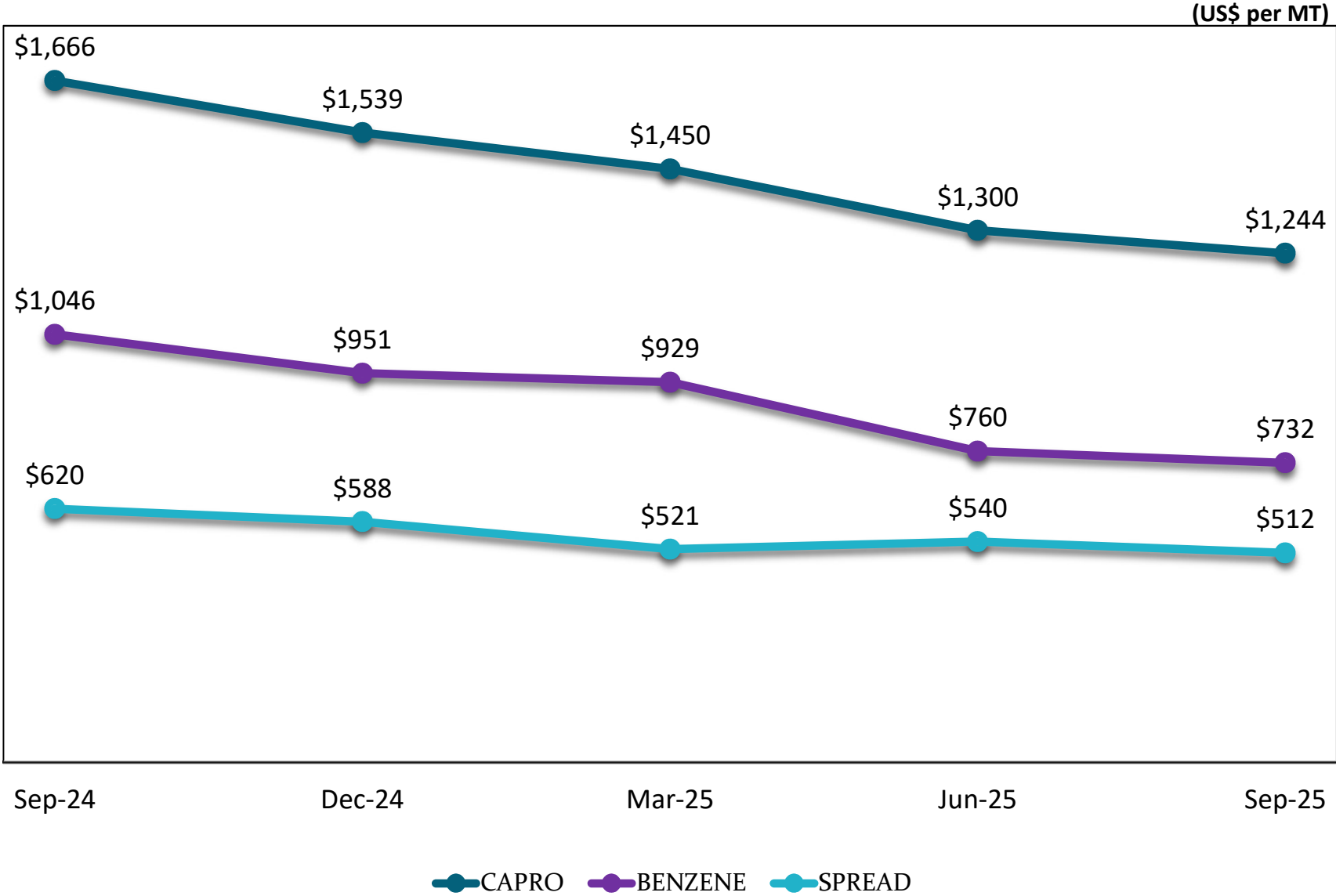

Natural Gas

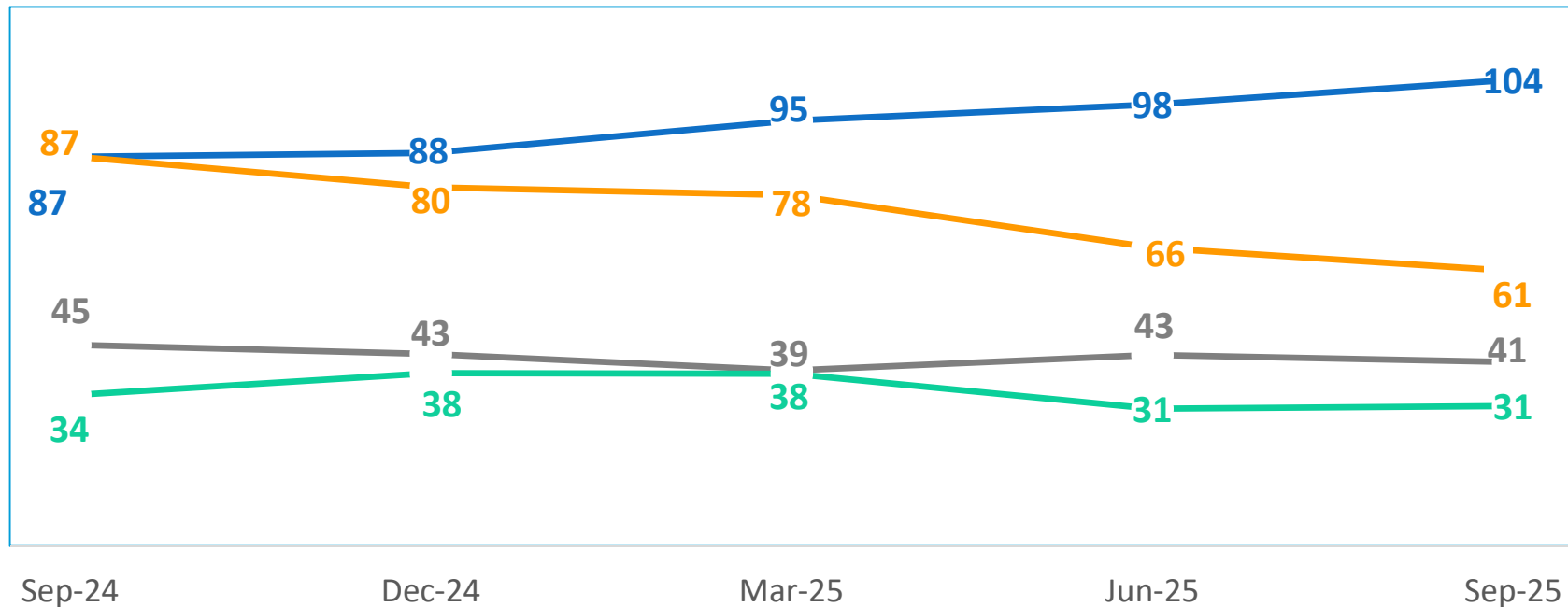
Changes in natural gas prices, a key raw material and energy source for operations

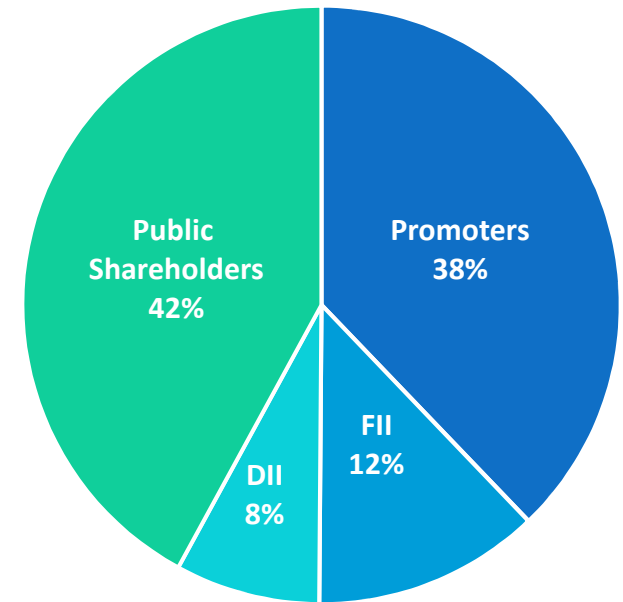
